

## Testifying Before a Kentucky State Legislature Committee

This past Tuesday, August 25, 2020, I testified before the Licensing, Occupations, and Administrative Regulations Committee of the Kentucky State Legislature during its Interim Session. The bill proposed is called the Mental Health Protection Act. It was often referred to as the "Conversion Therapy Ban" bill, but could most accurately be called the Censor Counseling Bill. No official action will be taken until January 2021 when the General Session convenes again, as its sponsors have promised to present the bill again.

Truth-telling and accuracy were in short supply in the testimonies of the four proponents of the bill; victimizing, gross exaggerations if not out-and-out lies, and false accusations were abundant; claims were made and statistics presented with no factual support—just a lot of sensationalizing. Plus, various LGBT organizations and our local newspaper have all put their colorful slant on the situation. But this is what we've come to.

Here is my testimony in its entirety.

"Mr. Chairman, and Distinguished Members of the Panel,

Thank you for your time today, and for allowing me to address this committee. My name is Daniel Mingo. I was raised in Lexington and for the last 30 years I've lived in Louisville.

I am here today to offer my perspective and experience regarding the advisability of passing the proposed Mental Health Protection Act, which would make it illegal for mental health workers

and licensed professional counselors to assist clients in reducing or overcoming their unwanted same-sex attractions or gender dysphoria.

To give some personal history, for nearly 30 years I lived a secret life in homosexuality. I was a born-again Christian man, a husband and father. Over the years, I had told a handful of pastors, hoping for some answers, but none seemed equipped to help me. I felt alone, scared for the future, and most of all trapped in the constant inner conflict of having committed my life to follow God yet dealing with feelings contrary to my faith convictions. I was unable to walk away on my own strength from that life of anonymous sexual encounters with men. In 1993, realizing I was feeding a sexual addiction, I went into a recovery program to overcome those compulsive behaviors. The first step in a twelve-step program is to admit that I was powerless over my behaviors and my life was unmanageable. That was 27 years ago.

I was sexually molested at 13 by an adult man. Stop and think about that for a moment. Interacting with males became sexualized for me by way of rape. I never wanted to be gay or adopt a gay lifestyle, but I was left with emerging same-sex attractions after being violated.

For the last 17 years, I have ministered to, and lay-counseled, same-sex attracted and gender dysphoric Christian individuals in Kentucky, who have LGBT feelings that, for **them**, are unwanted.

My concern about this proposed legislation is that it will hurt people that I care about. As presented, it offers protection to minors and vulnerable adults from coercive practices and aversion therapies by licensed counselors, but these techniques have not been practiced by professionals for decades already, as is evidenced by the total absence of lawsuits and revocations of licenses.

There are four issues I have with this proposed legislation.

First, if passed, this legislation will **censor counseling** to those <u>only</u> with unwanted same-sex attractions and gender dysphoria. These same individuals could receive help if they want to be gay, but not if they want to live a heterosexual life, following their religious convictions. That is discrimination. All people should have the choice to pursue counseling options that align with their personal life goals, and not be under government control.

Second, if this bill is passed, it would violate the guaranteed 1st Amendment free speech rights of secular counselors, pastoral counselors, and any other professionals named, whose beliefs are not in agreement with the bill's one-sided makeup. And if those beliefs which are not in agreement are religious in nature, and that being the very first one listed in the amendment, freedom of religion and the practice thereof, then those 1st Amendment rights would be violated as well.

Third, because this bill is proposed to protect children, if passed it would take away the basic rights of parents to freely choose the care they deem best for their sons and daughters. Would you want that right taken from you, whether an emotional, mental or physical condition, such that you could no longer choose what you believe is best for your children whom you love? Surely, there is a better option than removing these parental rights.

Finally, when parents bring sons or daughters desiring help to me for ministry, and we agree that professional psychological counseling is warranted, how do I tell them, if this bill is passed, that I cannot recommend licensed, professional care from a like-minded Christian practitioner, because Kentucky made that possibility illegal?

Thank you for your time and attention."

I urge you to read the article I've linked above, "The Campaign to Overthrow Straight America." It will open your eyes more clearly to the battle we're fighting, and hopefully bring you to your knees to do spiritual warfare on behalf of our state and country, and on behalf of those who are speaking the truth in the face of serious persecution. God help us going forward!
